Telangana State Level Police Recruitment Board invites Applications through **ONLINE** mode only in the prescribed proforma which will be made available on Website ([www.tslprb.in](http://www.tslprb.in)) from **2<sup>nd</sup> May 2022 to 20<sup>th</sup> May 2022** for recruitment to the following Posts –

#### **Eligibility Conditions:**

##### **A. Age Limit: (General)**

- i. For the Post Code Nos. 34 and 35: a) Must have attained the age of 18 years and must not have attained the age of 22 years as on 1<sup>st</sup> July, 2022 i.e., must have been born not earlier than 2<sup>nd</sup> July, 2000 and not later than 1<sup>st</sup> July, 2004.  
b) For Home Guards, a person, who as on the date of Notification has been on duty as Home Guard for a minimum duration of 360 days within a period of 2 (two) years and who is still continuing his service as Home Guard, must have attained the age of 18 years and must not have attained the age of 40 years as on 1<sup>st</sup> July, 2022 i.e., must have been born not earlier than 2<sup>nd</sup> July, 1982 and not later than 1<sup>st</sup> July, 2004.
- ii. For the Post Code No. 36: a) Must have attained the age of 21 years and must not have attained the age of 25 years as on 1<sup>st</sup> July, 2022 i.e., must have been born not earlier than 2<sup>nd</sup> July, 1997 and not later than 1<sup>st</sup> July, 2001.

b) For Home Guards, a person, who as on the date of Notification has been on duty as Home Guard for a minimum duration of 360 days within a period of 2 (two) years and who is still continuing his service as Home Guard, must have attained the age of 21 years and must not have attained the age of 40 years as on 1<sup>st</sup> July, 2022 i.e., must have been born not earlier than 2<sup>nd</sup> July, 1982 and not later than 1<sup>st</sup> July, 2001.

iii. For the Post Code No.34 (Women): In the case of a Widow, a Divorced Woman or a Woman judicially separated from her husband, and who is not remarried

a) SC & ST Candidates, must have attained the age of 18 years and must not have attained the age of 40 years as on 1<sup>st</sup> July, 2022 i.e., she must have been born not earlier than 2<sup>nd</sup> July, 1982 and not later than 1<sup>st</sup> July, 2004.

b) In all other cases (other than SC & ST), the Candidate must have attained the age of 18 years and must not have attained the age of 35 years as on 1<sup>st</sup> July, 2022, i.e., she must have been born not earlier than 2<sup>nd</sup> July, 1987 and not later than 1<sup>st</sup> July, 2004.

**However, the Government of Telangana vide GO Ms No. 48, General Administration (Services-A) Department dated 13-04-2022 have raised the upper age limit prescribed for appointment by direct recruitment by 3 (three) years for uniformed services including Police Department. This relaxation is in addition to the upper age limit as mentioned above.**

The details of upper age limit as applicable are shown in the detailed Notification

#### **B. Minimum Educational Qualification:**

i. For Post Code No. 34: Must have passed SSC or any other examination recognized by the State Government as being equivalent to SSC and must possess Industrial Training Institutional Certificate in Electronic, Mechanic OR Information Technology and Electronic System Maintenance OR Computer Operator and Programming Assistant OR Mechanic Consumer Electronics OR Electrician OR Vocational Intermediate in a) EET (Electronic Engineering Technician) b) ET (Electrical Technician) (old name Electrical Wiring and Servicing of Electrical applications (E.W & SEA) after SSC) as on 1<sup>st</sup> July 2022.

ii. For Post Code No. 35: Must have passed SSC or any other examination recognized by the State Government as being equivalent to SSC and must possess an Industrial Training Institutional Certificate in Wiremen OR Mechanic Motor vehicle OR Mechanic Diesel OR Fitter, as on 1<sup>st</sup> July 2022.

iii. For Post Code No. 36:

a. **Academic qualification**: Must have passed Intermediate examination or any other examination recognized as its equivalent by the State Board of Intermediate Education (OR) SSC or any other examination recognized by the State Government as being equivalent to SSC and must possess an Industrial Training Institutional Certificate in Auto Electrician OR Mechanic Motor vehicle OR Mechanic Diesel OR Fitter, as on 1<sup>st</sup> July 2022.

- b. **Technical Qualification:** Must have possessed either Light Motor Vehicle (Transport with Badge Number) or HMV License, or both put together, continuously for a period of full two years and above as on date of Notification.

Candidate should furnish the Driving Licence information (Grant of issue of Driving Licence), issued by the Licensing Authority of the RTA concerned along with the Application Form.

***Note: Candidates who possess higher qualification than the prescribed one will also be considered on par with the Candidates who possess the prescribed qualification***

**Fee:** OC and BC Candidates with Local status of Telangana State applying for the Posts of SCT PC (IT & CO), SCT PC (Mechanic) and SCT PC (Driver) have to pay a fee of Rs.800/- for each notified post towards Registration of the Application, Processing of Application, Conduct of Tests and Examinations, Maintenance of Portal etc. SC and ST Candidates who are Local to Telangana State have to however, pay only Rs.400/- for each post towards the same. All other Candidates will have to pay Rs.800/- for each notified post. As the testing Procedure and Examinations are different for these 3 Posts, fee has to be paid per each Post applied for. Fee may be paid through **Payment Gateway** (Credit Card / Debit Card / Internet Banking).

**Procedure:** Desirous and eligible Candidates may apply ON-LINE in the prescribed proforma which will be made available on Website ([www.tslprb.in](http://www.tslprb.in)) from **2<sup>nd</sup> May 2022 to 20<sup>th</sup> May 2022** for recruitment to the above Posts **only after satisfying themselves of the eligibility requirements as given in the Notifications**. Detailed information regarding Syllabi, Procedure for Online Application, distribution of vacancies, selection procedure, instructions to the candidate etc., is given in the **Notification** made available in the website [www.tslprb.in](http://www.tslprb.in).

**Note:** *Candidates have to fulfil the eligibility criteria laid down in the relevant GOs issued by the Government from time to time*
